We announce that at the Board of Directors meeting held on December 19, 2025, it was resolved that the following Organizational restructuring, change of management of executive officers, and personnel changes will be made, effective January 1, 2026

1. Organizational Changes

In order to promote our medium to long-term growth strategy, we will move from a division-based organization to a function-specific organization, strengthen our expertise, and optimize our management resources.

The A8 Department will be abolished. Consequently, the Market Development Division, Sales Division, Media Division, 1st Product Development Division, and 2nd Product Development Division will be reorganized into the 1st Sales Department, 2nd Sales Department, and Development Department.
